

State Fee Rates for Issue and Extension of Numbering Permits and Frequency Licences

1. A state fee for the issue or extension for one year of a frequency licence for a radio network with or without a basestation shall be paid in the following amount per radio frequency channel with a bandwidth of 25 kHz:
 - 1.1. 77 euros for a radio network without a base station, for local common use within the frequency band up to 87.5MHz;
 - 1.2. 155 euros for a radio network without a base station, for local exclusive use within the frequency band up to 87.5MHz;
 - 1.3. 155 euros for a radio network without a base station, for local common use within the frequency band 108 MHz to 174 MHz;
 - 1.4. 465 euros for a radio network without a base station, for local exclusive use within the frequency band 108 MHz to 174 MHz;
 - 1.5. 155 euros for a radio network without a base station, for local common use within the frequency band 230 MHz to 470 MHz;
 - 1.6. 385 euros for a radio network without a base station, for local exclusive use within the frequency band 230 MHz to 470 MHz;
 - 1.7. 155 euros for a radio network without a base station, for local common use within the frequency band 862 MHz and higher;
 - 1.8. 310 euros for a radio network without a base station, for local exclusive use within the frequency band 862 MHz and higher;
 - 1.9. 77 euros for a radio network with a base station, for local common use within the frequency band up to 87.5 MHz;
 - 1.10. 155 euros for a radio network with a base station, for local exclusive use within the frequency band up to 87.5MHz;
 - 1.11. 385 euros for a radio network with a base station, for local common use within the frequency band 108 MHz to 174 MHz;
 - 1.12. 770 euros for a radio network with a base station, for local exclusive use within the frequency band 108 MHz to 174 MHz;
 - 1.13. 235 euros for a radio network with a base station, for local common use within the frequency band 230 MHz to 470 MHz;
 - 1.14. 615 euros for a radio network with a base station, for local exclusive use within the frequency band 230 MHz to 470 MHz;
 - 1.15. 155 euros for a radio network with a base station, for local common use within the frequency band 862 MHz and higher;
 - 1.16. 310 euros for a radio network with a base station, for local exclusive use within the frequency band 862 MHz and higher.
2. A state fee in the following amount shall be paid per channel of a width of 100 kHz for the issue or extension for one year of a frequency licence to a mobile telephone network, access radio network or land mobile broadband radio network:
 - 2.1. 18 euros within the frequency band up to 2300 MHz;
 - 2.2. 9 euros within the frequency band of 2300 MHz to 4.2 GHz;
 - 2.3. 2 euros within the frequency band of 4.2 GHz to 6 GHz;
 - 2.4. 1 euro within the frequency band of 6 GHz to 24 GHz;
 - 2.5. 0.55 euros within the frequency band of 24 GHz and higher.
3. A state fee in the following amount shall be paid for the issue or extension for one year of a frequency licence for a paging system:
 - 3.1. 770 euros per channel of a width of 25 kHz in the case of provision of common access services within a system for exclusive use;
 - 3.2. 77 euros per channel of a width of 25 kHz within a system for exclusive use, except in the cases specified in clause 3.1;
 - 3.3. 385 euros per channel of a width of 25 kHz in the case of provision of common access services within a system for common use;
 - 3.4. 39 euros per channel of a width of 25 kHz within a system for common use, except in the cases specified in clause 3.3.
4. A state fee in the following amount shall be paid for the issue or extension for one year of a frequency licence for a transmitter of a fixed service:

- 4.1. 155 euros within the frequency band up to 30 MHz;
- 4.2. 23 euros within the frequency band 30 MHz to 174 MHz with a bandwidth of up to 50 kHz;
- 4.3. 77 euros within the frequency band 30 MHz to 174 MHz with a bandwidth of 50 kHz to 500 kHz;
- 4.4. 16 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of up to 50 kHz;
- 4.5. 39 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of 50 kHz to 500 kHz;
- 4.6. 77 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of 500 kHz to 4 MHz;
- 4.7. 155 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of higher than 4 MHz to 14 MHz;
- 4.8. 310 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of higher than 14 MHz to 100 MHz;
- 4.9. 770 euros within the frequency band 174 MHz to 3 GHz with a bandwidth of 100 MHz or higher;
- 4.10. 31 euros within the frequency band 3 GHz to 17 GHz with a bandwidth of up to 500 kHz;
- 4.11. 62 euros within the frequency band 3 GHz to 17 GHz with a bandwidth of 500 kHz to 4 MHz;
- 4.12. 77 euros within the frequency band 3 GHz to 17 GHz with a bandwidth of higher than 4 MHz to 14 MHz;
- 4.13. 235 euros within the frequency band 3 GHz to 17 GHz with a bandwidth of higher than 14 MHz to 100 MHz;
- 4.14. 385 euros within the frequency band 3 GHz to 17 GHz with a bandwidth of 100 MHz or higher;
- 4.15. 16 euros within the frequency band 17 GHz to 40 GHz with a bandwidth of up to 500 kHz;
- 4.16. 31 euros within the frequency band 17 GHz to 40 GHz with a bandwidth of 500 kHz to 4 MHz;
- 4.17. 39 euros within the frequency band 17 GHz to 40 GHz with a bandwidth of 4 MHz up to 14 MHz;
- 4.18. 77 euros within the frequency band 17 GHz to 40 GHz with a bandwidth of 14 MHz up to 100 MHz;
- 4.19. 155 euros within the frequency band 17 GHz to 40 GHz with a bandwidth of 100 MHz and higher;
- 4.20. 39 euros within the frequency band 40 GHz and higher with a bandwidth of up to 250 MHz;
- 4.21. 77 euros within the frequency band 40 GHz and higher with a bandwidth of higher than 250 MHz.
5. A state fee of 310 euros shall be paid for the issue or extension for one year of a frequency licence for a radar of afixed radio service for the observation of objects.
6. A state fee in the following amount shall be paid for the issue or extension of a frequency licence for one year for afixed radio network:
 - 6.1. 39 euros per radio frequency channel with a bandwidth of 25 kHz within the frequency band up to 0.4 GHz;
 - 6.2. 39 euros per radio frequency channel with a bandwidth of 25 kHz for common use within the frequency band upto 0.4 GHz;
 - 6.3. 310 euros within the frequency band 0.4 GHz to 1.9 GHz with a bandwidth of up to 50 kHz;
 - 6.4. 155 euros for common use within the frequency band 0.4 GHz to 1.9 GHz with a bandwidth of up to 50 kHz;
 - 6.5. 77 euros within the frequency band 1.9 GHz to 3 GHz with a bandwidth of up to 50 kHz;
 - 6.6. 39 euros for common use within the frequency band 1.9 GHz to 3 GHz with a bandwidth of up to 50 kHz;
 - 6.7. 155 euros within the frequency band 1.9 GHz to 3 GHz with a bandwidth of 50 kHz to 500 kHz;
 - 6.8. 77 euros for common use within the frequency band 1.9 GHz to 3 GHz with a bandwidth of 50 kHz to 500 kHz;

 - 6.14. 770 euros for common use within the frequency band 1.9 GHz to 3 GHz with a bandwidth higher than 14 MHzup to 100 MHz;
 - 6.15. 3070 euros within the frequency band 1.9 GHz to 3 GHz with a bandwidth of 100 MHz or higher;
 - 6.16. 1540 euros for common use within the frequency band 1.9 GHz to 3 GHz with a bandwidth of 100 MHz orhigher;
 - 6.17. 77 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of up to 500 kHz;
 - 6.18. 39 euros for common use within the frequency band 3 GHz to 10 GHz with a bandwidth of up to 500 kHz;
 - 6.19. 235 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 500 kHz to 4 MHz;

 - 6.24. 235 euros for common use within the frequency band 3 GHz to 10 GHz with a bandwidth higher than 14 MHz upto 100 MHz;
 - 6.25. 2310 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 100 MHz or higher;
 - 6.26. 1540 euros for common use within the frequency band 3 GHz to 10 GHz with a bandwidth of 100 MHz or higher;
 - 6.27. 31 euros within the frequency band 10 GHz to 17 GHz with a bandwidth of up to 500 kHz;
 - 6.28. 16 euros for common use within the frequency band 10 GHz to 17 GHz with a bandwidth of up to 500 kHz;
 - 6.29. 155 euros within the frequency band 10 GHz to 17 GHz with a bandwidth of 500 kHz to 4 MHz;
 - 6.30. 77 euros for common use within the frequency band 10 GHz to 17 GHz with a bandwidth of 500 kHz to 4 MHz;
 - 6.31. 235 euros within the frequency band 10 GHz to 17 GHz with a bandwidth of higher than 4 MHz to 14 MHz;
 - 6.32. 155 euros for common use within the frequency band 10 GHz to 17 GHz with a bandwidth higher than 4 MHz upto 14 MHz;
 - 6.33. 390 euros within the frequency band 10 GHz to 17 GHz with a bandwidth of higher than 14 MHz to 100 MHz;
 - 6.34. 195 euros for common use within the frequency band 10 GHz to 17 GHz with a bandwidth higher than 14 MHz upto 100 MHz;
 - 6.35. 1540 euros within the frequency band 10 GHz to 17 GHz with a bandwidth of 100 MHz or higher;
 - 6.36. 770 euros for common use within the frequency band 10 GHz to 17 GHz with a bandwidth of 100 MHz or higher;
 - 6.37. 39 euros within the frequency band 17 GHz and higher with a bandwidth of up to 500 kHz;
 - 6.38. 20 euros for common use within the frequency band 17 GHz and higher with a bandwidth of up to 500 kHz;
 - 6.39. 77 euros within the frequency band 17 GHz and higher with a bandwidth of 500 kHz to 4 MHz;
 - 6.40. 39 euros for common use within the frequency band 17 GHz and higher with a bandwidth of 500 kHz to 4 MHz;
 - 6.41. 155 euros within the frequency band 17 GHz and higher with a bandwidth of 4 MHz up to 14 MHz;
 - 6.42. 77 euros for common use within the frequency band 17 GHz and higher with a bandwidth higher than 4 MHz upto 14 MHz;
 - 6.43. 235 euros within the frequency band 17 GHz and higher with a bandwidth of 14 MHz up to 100 MHz;
 - 6.44. 155 euros for common use within the frequency band 17 GHz and higher with a bandwidth higher than 14 MHz upto 100 MHz;
 - 6.45. 615 euros within the frequency band 17 GHz and higher with a bandwidth of 100 MHz and higher;
 - 6.46. 310 euros for common use within the frequency band 17 GHz and higher with a bandwidth of 100 MHz or higher.
7. A state fee in the following amount shall be paid for the issue or extension for one year of a frequency licence for afixed ground-based radio transmitter, including a navigation transmitter, used for communication with water craft or aircraft:
 - 7.1. 155 euros within the frequency band of 30 kHz to 30 MHz;
 - 7.2. 62 euros within the frequency band of 30 MHz to 30 GHz;
 - 7.3. 62 euros within the frequency band of 30 GHz and higher.
 8. A state fee of 310 euros shall be paid for the issue or extension for one year of a frequency licence for a ground-based radar of a radio service for the observation of objects in water or on land.
 9. A state fee in the following amount shall be paid for the issue or extension for one year of a frequency licence for aground-based radio network, used for communication with water craft or aircraft:
 - 9.1. 155 euros per each frequency band within the frequency bands of 117.975 MHz to 144.000 MHz; 156.000 MHz to 162.050 MHz; 457.525 MHz to 457.575 MHz and 467.525 MHz to 467.575 MHz;
 - 9.2. 235 euros within the frequency band of 30 kHz to 30 MHz.
 10. A state fee in the following amount shall be paid for the issue or extension for one year of a frequency licence for afixed satellite earth station or complementary land component:
 - 10.1. 120 euros within the frequency band up to 3 GHz with a bandwidth of up to 0.1 MHz;
 - 10.2. 615 euros within the frequency band up to 3 GHz with a bandwidth of 0.1 MHz to 1 MHz;
 - 10.3. 1160 euros within the frequency band up to 3 GHz with a bandwidth of 1 MHz to 10 MHz;

- 10.4. 1730 euros within the frequency band up to 3 GHz with a bandwidth of 10 MHz to 50 MHz;
- 10.5. 6140 euros within the frequency band up to 3 GHz with a bandwidth of 50 MHz or higher;
- 10.6. 77 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of up to 0.1 MHz;
- 10.7. 235 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 0.1 MHz to 1 MHz;
- 10.8. 615 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 1 MHz to 10 MHz;
- 10.9. 770 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 10 MHz to 50 MHz;
- 10.10. 2310 euros within the frequency band 3 GHz to 10 GHz with a bandwidth of 50 MHz or higher;
- 10.11. 39 euros within the frequency band 10 GHz and higher with a bandwidth of up to 0.1 MHz;
- 10.12. 235 euros within the frequency band 10 GHz and higher with a bandwidth of 0.1 MHz to 1 MHz;
- 10.13. 465 euros within the frequency band 10 GHz and higher with a bandwidth of 1 MHz to 10 MHz;
- 10.14. 615 euros within the frequency band 10 GHz and higher with a bandwidth of 10 MHz to 50 MHz;
- 10.15. 2310 euros within the frequency band 10 GHz and higher with a bandwidth of 50 MHz and higher;
- 11.** A state fee in the amount of 77 euros shall be paid for the issue or extension of a frequency licence for one year for a standard frequency and time signal service transmitter.
- 12.** A state fee in the following amount shall be paid for the issue or extension of a frequency licence for one year for a broadcasting network radio transmitter:

 - 12.12. 155 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of up to 10 W;
 - 12.13. 310 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 10 W to 100 W;
 - 12.14. 615 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 100 W to 1 kW;
 - 12.15. 1540 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 1 kW to 10 kW;
 - 12.16. 3070 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 10 kW to 100 kW;
 - 12.17. 6140 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 100 kW to 1 MW;
 - 12.18. 12,280 euros within the frequency band up to 26.1 MHz or 47 MHz to 87.5 MHz or 174 MHz to 240 MHz with non-directional radiated power of 1 MW or higher;
 - 12.19. 310 euros per radio frequency band with a bandwidth of 8 MHz within the frequency band 3.6 GHz and higher.
- 13.** A state fee for the issue or extension for a period of three years of a radio permit for water craft or aircraft is paid as follows:
 - 13.1. a state fee 39 euros per frequency range entered in a radio permit for a water craft or aircraft shall be paid for the issue or extension of a radio permit for a water craft or aircraft within the frequency bands 17.975 MHz to 144.0 MHz; 155.000 MHz and 155.525 MHz and 156 MHz to 162,025 MHz;
 - 13.2. a state fee of 77 euros per frequency range entered in a radio permit for a water craft or aircraft shall be paid for the issue or extension of a radio permit for a water craft or aircraft within the frequency bands 110 kHz to 150 kHz; 405 kHz to 535 kHz; 1605 kHz to 4000 kHz; 1605 kHz to 3800 kHz; 3800 kHz to 4000 kHz; 4000 kHz to 27 500 kHz; 4200 MHz to 4400 MHz and 8750 MHz to 8850 MHz;
 - 13.3. a state fee of 235 euros per frequency range entered in a radio permit for a water craft or aircraft shall be

paid for the issue or extension of a radio permit for a water craft or aircraft within the frequency bands 457.525 MHz to 457.575 MHz; 467.525 MHz to 467.575 MHz; 2900 MHz to 3100 MHz; 5350 MHz to 5460 MHz and 9300 MHz to 9500 MHz;

- 13.4. a state fee of 310 euros shall be paid for the entry, for a period of up to three years, of earth stations used based on a frequency licence on a radio permit of a water craft or aircraft.
14. A state fee of 77 euros shall be paid for the issue or extension for one year of a frequency permit for mobile or portable earth stations.
15. A state fee shall be paid for the issue or extension of a numbering permit for one year as follows:
 - 15.1. for the issue or extension for one year of a numbering licence granting the right to use of a carrier access code for the provision of voice services, a state fee shall be paid in the following amounts:
 - 1) 15,980 euros in the case of a three-digit carrier access code;
 - 2) 11,510 euros in the case of a four-digit carrier access code;
 - 3) 3840 euros in the case of a five-digit carrier access code;
 - 15.2. a state fee of 195 euros shall be paid for the issue or extension for one year of a numbering licence granting the right to use of an identification code;
 - 15.3. for the issue or extension for one year of a numbering licence not specified in clause 15.1 which grants the right to use a short code, a state fee shall be paid in the following amounts:
 - 1) 770 euros if the short code consists of five digits;
 - 2) 1540 euros if the short code consists of four digits;
 - 3) 15,340 euros if the short code consists of three digits;
 - 15.4. 0.35 euros per each number permitted to be used shall be paid upon the issue or extension for one year of a numbering licence which gives the right to use numbers, except in the cases specified in clauses 15.1–15.3, 15.5 and 15.7;
 - 15.5. a state fee of 155 euros per number permitted to be used shall be paid for the issue of a numbering licence which grants permission for the use of service numbers in the numbering range "800", "900" or "901" or for the extension of such permit for up to one year;
 - 15.6. upon amendment of the numbering licences specified in clauses 15.4, 15.5 and 15.7, a state fee for additional numbers shall be paid in proportion to the full months remaining until the time of expiry of the corresponding numbering licence; licence.
 - 15.7. a state fee of 0.01 euros per number permitted to be used shall be paid for the issue of a numbering licence which grants permission for the use of twelve-digit numbers or for the extension of such permit for up to one year;
 - 15.8. a state fee of 0.05 euros per number permitted to be used shall be paid for the issue of a numbering licence which grants permission for the use of ten-digit numbers or for the extension of such permit for up to one year.
